Anthony Hamm, DC, FACO and Ricky Sides, DC will update the attendees on current Center for Medicare and Medicaid Services' (CMS) rules and regulations with respect to the practice of chiropractic. The session will review key approaches to proper Medicare documentation, diagnostic reporting and correct claims filing.

Dr. Hamm & Dr. Sides will discuss current documentation requirements in the chiropractic practice. Topics include compilation of the patient record, intake forms, history, examination, radiology, physical medicine and rehabilitation and discharge. Finally, there will be a discussion relating to proper coding to report the services performed in a typical chiropractic practice. The coding portion will be pertinent to North Carolina claims.

DO YOU KNOW HOW TO HANDLE AN AUDIT?

Dr. Hamm will discuss the current trends dealing with chiropractic practice audits. Topics will include the different types of audits, both in private payer and federally funded plans such as Medicare and Medicaid. They will also discuss self audits, compliance issues and what to do if audited.
